Deposit Insurance Organization of the Year 2007 is Fundo Garantidor Creditos (FGC) Brazil

The **Deposit Insurance Organisation of the Year 2007 Award** is handed over to **Antonio Carlos Bueno de Camargo Silva**, CEO of **FGC**, by **Guy St Pierre**, CEO of **CDIC (Canada)**, last year's Winner of the DIO Award. (2006).

On behalf of the Members of the International Association of Deposit Insurers, J P Sabourin, Chair of the Executive Council and President, is pleased to announce that Fundo Garantidor de Créditos (FGC) Brazil has been selected as the Deposit Insurance Organization of the Year for 2007.

In making the announcement, Mr **Sabourin** said that "the **FGC** has clearly demonstrated that it has, over the past 11 years since its establishment, fulfilled its mandate and used its powers to protect depositors and contribute to the stability of the Brazilian financial system." **FGC**'s performance was evaluated by the Fundação Instituto Miguel Calmon de Estudos Sociais e Econômicos, based on a comparative analysis of 5,000 large corporations in Brazil. **FGC** was recently awarded the "Best Corporation in Brazil" and the "Best Corporation in the Southeastern Region" in the Financial Intermediation Sector in 2006.

Mr Sabourin also noted that **Antonio Carlos Bueno de Camargo Silva** (CEO) and **Carlos Henrique de Paula** (Director) were awarded the Honorary Title of Goias Citizens, by the Legislative Assembly of the State of Goias for their services rendered to the Goias society during the course of the Extrajudicial Liquidation Process of the BBC Bank.

FGC is one of the founding members of **IADI**. It has contributed actively to the Association through its representation on the Executive Council over a five year period. In addition, **FGC** has actively supported the initiatives of the Latin America Regional Committee. Mr **Sabourin** said "these efforts have demonstrated results in the advancement of regional awareness and a greater appreciation of deposit insurance issues in the Latin America region".
